Introduction and welcome	<b>1.</b> The Chair (PA) welcomed the BACACG members to the meeting.
Matters arising from the last meeting	<b>2.</b> CIM Clayfield’s initials were incorrectly listed on page 4 of the previous minutes. 6. Mark Willey presented the latest Noise Complaints data.

8. The group reviewed the notes from the last Brisbane Airport Community Forum. The group expressed an interest in seeing data from past Community Forums, grouped by category, in order to understand trends & identify key areas of community concern. BAC to provide this at the next meeting.

Presentations

**9. Presentation – The New Parallel Runway Project**

Paul Coughlan gave a presentation on the New Parallel Runway project.

Questions from the BACACG:

- CIM Clayfield – Why won't the new runway be 3,600m long, like the existing runway?
  - PC – The new runway will be 3,300m long, because at present there are only about two flights each day that require a 3600m runway, thus it is not felt that another 3,600km runway is needed.
  - MY – We are also keeping costs down by not building what we don't need.
  - CIM Griffith – Can you tell me how many flights are expected to take off and land over the bay/city during noise sensitive periods, once the new runway is operational?
  - PC – I can provide those figures at the next meeting.
  - CIM Griffith – Will improvements in technology mean

that more aircraft will be able to fly over the bay in future, even if weather or wind conditions are undesirable?

- PC – I don't think so. The standards that we have in Brisbane are world's best practice, I don't foresee CASA relaxing their current regulations.
- CIM Moreton – You mention that you used weather data from 1995 during the EIS because of the drought. Have you considered looking forward? The CSIRO has done a lot of modeling on this.
- PC – No, we felt it was more accurate to use historic weather data.
- CIM Griffith – Compared with previous master plans, you have moved the runway 2.2kms closer to Moreton Bay. What level of noise reduction is being achieved by doing this?
- PC – The difference to residents living under some flight paths would be a few decibels. I can find out what the difference is predicted to be using our TNIP program, and report back at the next meeting.
- CIM Griffith – Did you research the possibility of building the new runway out into the bay?
- PC – We did. There were quite a number of issues which would have arisen including - building in to a marine park, native title issues, as well as cost. The cost of building the runway into the bay could be as much as \$6 billion.
- MP – Is there a new terminal planned?
- PC – It's not expected that Brisbane will need a new terminal for many years.

## Presentations

### 10. Presentation – Noise Monitoring

Michael Wright from Airservices Australia gave a presentation about the Noise Monitoring systems located around Brisbane.

Questions from the BACACG:

- CIM Griffith (in reference to the increased number of noise complaints since the announcement of a noise ombudsman) – Could a spike in the number of complaints be attributed to population growth? The group discussed the challenges of population growth in Brisbane, especially with consideration to developments in areas under future flight paths.
  - CIM Clayfield – I understood that there were only four

noise monitoring stations and that one had been closed down. You mentioned five noise monitoring stations in your presentation.

- MW – I think one was closed temporarily for maintenance, but I will double-check this and report back to the group.
- CIM Clayfield – I feel that the noise monitors are very far away from the end of the runway. Why are there no monitors closer to the airport? *The group discussed the current locations of the noise monitors in relation to the flight paths.*
- MW – AirServices does have some portable noise monitors. If the group wanted to make a recommendation that a temporary monitor be placed in a particular location, we would consider doing that.
- CIM Moreton – It would be interesting to see where complaints are coming from on a map, in relation to where noise monitors are located.
- CIM Moreton - It would also be interesting to see designated flight paths & actual paths flown by aircraft layered over complaint data. Or a map showing known N70 noise events and complaint data. *(BAC/Airservices to discuss whether this data could be collated, and report back at the next meeting).*
